### **Pinal-Gila Council for Senior Citizens** Community Needs Assessment 2023

Pinal-Gila Council for Senior Citizens (PGCSC) conducted a community needs assessment in Pinal and Gila Counties to assess the needs of seniors. The assessment was conducted in early 2023. The assessment was part of PGCSC's Area Plan for 2023-2027.

The assessment included a set of questions that surveyed the needs of seniors, as understood by the person completing the survey. All areas in Pinal and Gila counties were targeted, and a wide response was received from all areas of the two counties.

In order to reach out to a wide variety of people, the survey was distributed through a targeted mailing list, clients receiving PGCSC services, elected officials, local businesses, health care providers, etc. The survey was also made available online on the PGCSC website, through social media, and through several other sources that helped to promote the survey.

A total of 578 surveys were completed, with 324 surveys completed in Pinal County, and 116 completed in Gila County.
